1.0 Plan Summary Statement

This toxic substance reduction plan summary for Zinc (and its Compounds) accurately reflects the content of the toxic substance reduction plan for Traxle Manufacturing, a Division of Linamar Corporation (Traxle), dated December 31st, 2017.

2.0 Description of the Toxic Substance

Zinc (and its compounds) is a constituent of the raw materials used in the manufacturing of parts for the automotive industry. Zinc (and its compounds) is not created on-site.

3.0 Statement of Intent

Traxle is committed to playing a leadership role in protecting the environment. Where feasible, Traxle reduces the use of Zinc (and its compounds) in compliance with all applicable Federal and Provincial regulations.

4.0 Objectives

The objective was to identify feasible reduction options to reduce the use of Zinc (and its compounds) on-site.

5.0 Reduction Options to Be Implemented

The facility was unable to identify any reduction options that are both technically and economically feasible. Therefore, no reduction options to reduce the use of Zinc (and its compounds) will be implemented at the facility at this time.
